GENERAL TERMS AND CONDITIONS OF SALE (GTCS)

Romberg GmbH & Co. KG, Werner-v.-Siemens-Str.13, 25479 Ellerau, Germany

1. Scope of application and contracting partners

- 1.1 The present General Terms and Conditions of Sale (hereinafter "GTCS") shall become the content for all offers, deliveries and services of Romberg GmbH & Co. KG (hereinafter "Romberg") in relation to its customers. The GTCS apply in particular to contracts for the sale and/or delivery of movable goods (hereinafter "goods"), regardless of whether Romberg manufactures goods itself or purchases them from suppliers.
- 1.2 Deviating, conflicting or supplementary General Terms and Conditions of the customers shall only become part of the contract if and to the extent that Romberg has expressly agreed to their validity. The requirement for consent shall also not be waived if Romberg accepts the delivery to the customer without having objected to its General Terms and Conditions or in the event that the customer refers to its GTC when confirming an order.
- 1.3 The present GTCS shall only apply in business transactions with entrepreneurs pursuant s 14 BGB German Civil Code, i.e., natural or legal persons or partnerships with legal capacity who, when concluding the legal transaction, act in the exercise of their commercial or independent professional activity, as well as legal persons under public law and special funds under public law. Since Romberg's offer is directed only at commercial market participants, Romberg may require the customer to provide sufficient proof of its entrepreneurial status prior to the conclusion of the contract, e.g., by providing the VAT ID number or other suitable proof (trade license or similar). The data required for the proof must be provided completely and truthfully.
- 1.4 The provisions on general obligations in electronic commerce pursuant to s 312i (1) sentence 1 nos. 1-3 BGB shall not apply to the contract concluded between the parties.

2. Offer, conclusion of the contract

- 2.1 The presentation of goods in online and offline media, catalogs, flyers, brochures, advertisements and other advertising material does not constitute an offer in the legal sense, but merely an invitation to the customer to make an offer.
- 2.2 Romberg may accept an offer from the customer within four weeks. Purchase orders received by Romberg shall be deemed to be a binding offer by the customer to conclude the contract.
- 2.3 The customer is required to accept offers from Romberg within the period customary in the industry, at the latest within a period of 2 weeks. Late acceptance shall be deemed a new offer and shall require acceptance by Romberg.
- 2.4 The contract is concluded by the order confirmation from Romberg. The order confirmation may at Romberg's discretion be effected by execution of the delivery or service or by sending the invoice.
- 2.5 The documents belonging to the offer from Romberg, such as illustrations, drawings, indications of weight, color, packaging and dimensions of goods, are only approximative, unless they are expressly designated as binding or the usability of the object of the delivery or service for the contractually intended purpose does require an exact match. Reasonable and insignificant quality and quantity tolerances customary in the trade and deviations that occur due to legal regulations, result from the natural origin of the materials or represent technical improvements, as well as the replacement of components with equivalent parts are permissible, provided that they do not impair the usability for the contractually intended purpose. The aforementioned characteristics of goods to be delivered or services to be rendered are not guaranteed characteristics even in the case of a binding agreement, unless they are expressly designated as a guarantee.

3. Prices

- 3.1 The prices shall apply to the scope of delivery and services listed in Romberg's order confirmation. Additional or special services will be charged separately.
- 3.2 Prices are quoted in Euro ex works, plus the statutory value-added tax and any other duties, taxes, fees or other public charges that may be incurred.
- 3.3 The cost of packaging is included in the price, unless otherwise agreed. The shipping costs are presented according to the costs incurred for the respective country. The customer has to bear the shipping costs communicated to him.
- 3.4 If the agreed price is based on Romberg's price list and if the delivery is to take place more than four months after the conclusion of the contract, the prices which may have increased as a result of general price increases shall apply in accordance with Romberg's price list valid at the time of delivery (any agreed discounts shall remain unaffected and shall also apply to the changed price), whereby the customer shall have a special right of withdrawal in the event of a price increase of more than eight percent.
- 3.5 With the publication of a new price list or a new catalog, all previous price lists otherwise lose their validity.

4. Delivery time and delivery periods; dispatch; transfer of risk; place of performance

- 4.1 Deadlines and dates for deliveries and services stated by Romberg shall only be approximate unless the parties have expressly agreed on a fixed deadline or a fixed date. If shipment has been agreed, delivery periods and delivery dates shall refer to the time of handover to the forwarder or carrier.
- 4.2 Unless expressly agreed otherwise, delivery shall be ex works or ex warehouse, which is also the place of performance for the delivery and any subsequent performance. At the customer's request and expense, the goods shall be shipped to another destination (sale by delivery to a place other than the place of performance). If the parties have not agreed on the mode or route of shipment, both shall be determined by Romberg.
- 4.3 Delivery is made to the delivery address specified by the customer, unless otherwise agreed.
- 4.4 If a delivery deadline or delivery date cannot be met for a reason for which Romberg is not responsible, e.g. as a result of force majeure, war, riots, pandemics and pandemic-related consequences or restrictions, strikes, lockouts, import and export embargoes, seizures, embargoes, shortages of raw materials and energy, manufacturing or delivery disruptions at a supplier of Romberg or other unforeseeable obstacles that cannot be eliminated by reasonable means, Romberg shall inform the customer of this immediately and provide a new delivery date. If delivery is impossible or delayed in whole or in part through no fault of Romberg, the customer shall not be entitled to any claims for damages against Romberg. However, Romberg shall be obligated to assign to the customer any claims for compensation against the upstream supplier.
- 4.5 The occurrence of a delay in delivery by Romberg shall be determined in accordance with the statutory provisions. In any case, however, a reminder by the customer is required.
- $4.6\ Partial\ deliveries\ shall\ be\ permissible\ if\ the\ partial\ delivery\ is\ reasonable\ for\ the\ customer,$ i.e., it is usable within the scope of the contractual intended purpose, the delivery of the remains

- ning part is ensured and the customer does not incur significant additional expenses and costs (unless Romberg agrees to bear such costs). This shall not affect the content of the contract, in particular the performance owed by Romberg or the agreed performance time.
- 4.7 The risk of accidental loss and accidental deterioration of the goods shall pass to the customer upon handover of the delivery item to the forwarding agent, carrier or any other third party designated to carry out the shipment. Decisive for the transfer of risk is the beginning of the loading process. This handover shall be the same if the customer is in default of acceptance.
- 4.8 If the customer is in default of acceptance, fails to cooperate or if Romberg's delivery is delayed for other reasons for which the customer is responsible, Romberg shall be entitled to demand compensation for the resulting damage, including additional expenses (e.g., storage costs). For this purpose, Romberg shall charge a lump-sum compensation in the amount of 0.5% of the price of the order per calendar week, starting with the delivery deadline or in the absence of a delivery deadline with the notification that the goods are ready for shipment, up to a maximum of 5% in the event of final non-acceptance. The proof of higher damages and the statutory claims of Romberg shall remain unaffected; however, the lump sum shall be credited against further monetary claims. The customer shall have the right to prove that Romberg has incurred no damage at all or only significantly less damage than the aforementioned lump sum.
- $4.9\,\mathrm{The}$ rights of the buyer and the statutory rights of Romberg, in particular in the event of an exclusion of the obligation to perform, shall otherwise remain unaffected.

5. Payment

- 5.1 Unless otherwise agreed in writing, Romberg's invoices shall be due for payment without deduction within 30 days of receipt of the invoice.
- 5.2 After expiry of this period, the customer shall be in default of payment. In the event of default in payment, the customer shall be obliged to pay default interest at the statutory default interest rate applicable at the time. With respect to merchants, Romberg's claim to the commercial due date interest rate shall remain unaffected (s 353 HGB German Commercial Code). If Romberg accepts checks, they shall not be deemed to be fulfilled until they have been cashed. Romberg reserves the right to assert further damage caused by delay.
- 5.3 Romberg shall be entitled at any time, also within the framework of an ongoing business relationship, to make a delivery in whole or in part only against advance payment. Romberg shall declare a corresponding reservation at the latest with the order confirmation.

6. Reservation of title

- 6.1. Romberg shall retain title to the delivered goods (goods subject to retention of title) until all claims to which Romberg is entitled against the customer arising from the business relationship have been settled.
- 6.2. In the event of conduct on the part of the customer in breach of the contract, in particular in the event of default in payment, in the event of false information regarding his creditworthiness or if an application for the opening of insolvency proceedings has been filed, Romberg shall be entitled to withdraw from the contract in accordance with the statutory provisions and to demand the return of the reserved goods, insofar as the customer has not yet fully rendered the consideration. If the customer does not pay the purchase price due, Romberg may only assert these rights if the customer has been set a reasonable deadline for payment or if setting a deadline is dispensable in accordance with the statutory provisions.
- 6.3. The taking back of the reserved goods or their seizure by Romberg shall constitute a withdrawal from the contract. The customer shall bear the transport costs incurred for the taking back. Romberg shall be entitled to dispose of any goods subject to retention of title that have been taken back. The proceeds of the realization less the costs of the realization shall be offset against outstanding claims of Romberg.
- 6.4. The customer is entitled to resell the reserved goods in the ordinary course of business. The customer hereby assigns to Romberg all claims accruing to it from the resale in the amount of the invoice amount against purchasers or third parties. Romberg hereby accepts this assignment. The customer shall be authorized to collect the assigned claims in its own name. The authority of Romberg to collect the claim shall remain unaffected by this, but Romberg shall not collect the claim as long as the customer duly meets its payment obligations and is not in default of payment. If the customer is in default of payment, Romberg may obtain that the customer discloses the assigned claims and their debtors, provides all information necessary for collection, hands over the associated documents and informs the debtors (its customers or third parties) of the assignment, which must be proven to Romberg immediately.
- 6.5. Treatment and processing of the reserved goods shall be carried out for Romberg as manufacturer, without any obligations arising for Romberg as a result. If the reserved goods are processed, inseparably combined or mixed with other objects not belonging to Romberg, Romberg shall acquire pro rata co-ownership of the new object. This shall correspond to the value of the reserved goods in relation to the values of the items not belonging to Romberg immediately before the time of their processing, combination or mixing. The co-ownership rights thus created shall be deemed to be reserved goods within the meaning of these terms and conditions. If the combination or mixing takes place in such a way that an item belonging to the customer is to be regarded as the main item, the customer shall be obliged to transfer co-ownership to Romberg on a pro rata basis insofar as the main item belongs to the customer.
- 6.6 The customer shall be obligated to store the reserved goods for Romberg with due commercial care and to insure them at its own expense against theft and fire and water damage. The customer hereby assigns any future claim against the insurer to Romberg, and Romberg accepts this assignment.
- 6.7 Goods subject to retention of title may not be pledged or assigned as security until the secured claims have been paid in full. If the goods subject to retention of title are transferred to a third party by way of security in breach of contract, the customer hereby assigns to Romberg its expectant right as well as its retransfer claim under this agreement. Romberg accepts this assignment. Access by third parties shall be reported to Romberg by the customer in writing without felax.
- 6.8 If the collateral provided exceeds 110% of the claims secured under this Clause 6 of the GCS (cover limit), Romberg shall be obligated, at the customer's request, to release such collateral as exceeds the aforementioned cover limit.
- 6.9 The customer requires Romberg's written consent for the assignment of his claims arising from the purchase contract with his customer. He affirms that he has not yet disposed of these claims in any other way.

7. Warranty; duty to inspect and give notice of defects of the customer

- 7.1 The existence of a defect shall be determined in accordance with the statutory provisions, with the proviso that the determination thereof shall first be based on the use of the goods contractually agreed between Romberg and the customer, or alternatively on the use of the goods presumed by the parties.
- 7.2 The customer's rights in the event of material defects and defects of title (including incorrect and short delivery as well as improper assembly/installation or defective instructions) shall be the statutory provisions, unless otherwise stipulated in Clause 8 (Liability).
- 7.3 For merchants, ss 377, 381 HGB apply with the following proviso: delivered goods are to be inspected by the customer immediately after delivery. They shall be deemed to have been approved if Romberg does not receive a notice of defects within 7 working days after delivery in the case of obvious defects or defects which are recognizable after careful examination, and in the case of other defects immediately after their discovery.
- 7.4 In the event of justified and timely notification of defects by the customer, Romberg shall be entitled and obligated to subsequent performance within the scope of the statutory regulations.
- 7.5 The customer shall be entitled to the statutory claims, if the subsequent performance fails. In the event of a replacement delivery, the buyer shall return the defective item at Romberg's request in accordance with the statutory provisions; however, the customer shall not have a right of return.
- 7.6 Subsequent performance does not include the removal, dismantling or deinstallation of the defective item, nor the installation, fitting or fitting of a defect-free item if Romberg was not originally obliged to perform these services; any claims of the customer for reimbursement of corresponding costs remain unaffected.
- 7.7 Rejected goods must be kept at Romberg's disposal. The customer shall be obligated to give Romberg the opportunity to inspect the goods. Romberg shall reimburse the expenses necessary for the purpose of subsequent performance, in particular transport, return, travel, labor and material costs, as well as any dismantling and installation costs incurred, in accordance with the statutory provisions and these GTCS, if the notice of defect is either justified or the customer was unable to establish, during the required careful inspection of the goods to be carried out in accordance with its possibilities, that the defect does not exist or that Romberg is not responsible for the defect. Romberg may demand reimbursement from the customer of the costs incurred as a result of the unjustified request to remedy the defect if the purchaser knew or was negligent in not knowing, for the reasons stated above, that there was in fact no defect.
- 7.8 The warranty period is one year from delivery.
- 7.9 Claims of the customer against Romberg for payment of damages shall be limited in accordance with the following Clause 8 (Liability).

8. Liability

- 8.1 Romberg shall always be fully liable without limitation for personal injury (injury to life, body and health) as well as for damage caused intentionally or by gross negligence and in the event of liability under the Product Liability Act. This shall also include unlimited liability for fraudulently concealed defects or the absence of a quality for which Romberg has assumed a guarantee.
- 8.2 In all cases of slight negligence, Romberg shall only be liable in the event of a breach of a material contractual obligation, limited to the foreseeable, typically occurring damage. Material contractual obligations are obligations the fulfillment of which makes the proper execution of the contract possible in the first place and on the observance of which the customer may regularly rely. There shall be no further liability.
- 8.3 The above limitations of liability shall also apply with regard to legal representatives and vicarious agents of Romberg.
- 8.4 Neither party shall be liable for non-performance or delayed performance caused by any of the following: acts of war or hostilities, sabotage, natural disasters; pandemics and pandemic-related consequences or restrictions; power, telecommunications, and Internet outages beyond the control of the party obligated to perform; governmental or regulatory restrictions (including denial or cancellation of export or other permits); or other events beyond the control of the party obligated to perform. The same shall apply if such circumstances occur at Romberg's vicarious agent. In such a case, the performance time shall be extended to a reasonable extent. Both parties shall endeavor to minimize the effects of such events and to take appropriate countermeasures.

9. Supplier recourse

- 9.1 In all cases, the special statutory provisions on reimbursement of expenses in the case of final delivery of the newly manufactured goods to a consumer (supplier recourse pursuant to ss 478, 445a, 445b or ss 445c, 327 subs. 5, 327u BGB) shall remain unaffected.
- 9.2 In the event of a supplier recourse, the customer shall be obligated to obtain the goods provided within the scope of a subsequent delivery from Romberg, unless this is unreasonable for the customer due to an important reason.

10. Set-off and retention

- 10.1 The customer shall only have a right of set-off if its counterclaims have been legally established, acknowledged or not disputed by Romberg. The customer's right to set-off against contractual and other claims arising from the initiation or execution of this contractual relationship, in particular due to defects of the delivered goods, shall remain unaffected.
- 10.2 The customer may only exercise a right of retention if its counterclaim is based on the same contractual relationship.

11. Note on the Electrical and Electronic Equipment Act

- 11.1 Electrical and electronic equipment that has become waste, for example because it is defective or no longer needed, is referred to as waste electrical and electronic equipment (hereinafter: "waste electrical and electronic equipment"). Users must not dispose of old equipment with normal household waste, but must collect it separately from unsorted municipal waste. This means that old equipment must be collected and disposed of ("collected") separately by the user. This is possible, for example, via the local
- collection and return systems. The symbol of the crossed-out wheeled bin shown below indicates that WEEE must be collected separately from unsorted municipal waste by the user:

- 11.2 The user is obliged to remove used batteries and accumulators that are not enclosed by the waste equipment or firmly attached to it before handing them over to a collection point. The same applies to lamps that can be removed from the waste equipment without destroying it. The obligation to remove does not apply if WEEE is separated in accordance with s 14 (4) sentence 4 or (5) sentences 2 and 3 Elektro6
- German Electrical and Electronic Equipment Act in order to prepare it for reuse.
- 11.3 According to s 17 (1) and (2) ElektroG, distributors (suppliers) of electrical and electronic equipment are obliged to take back old equipment free of charge if end users purchase a new electrical or electronic device of the same type that essentially fulfills the same functions as the new device. At the end user's request, they will also take back old equipment free of charge and irrespective of the purchase of a new electrical or electronic appliance if it does not exceed 50 cm in any external dimension. The latter is limited to five old devices per type of device and end user. Romberg will take back old equipment from the end user in the context of orders for new equipment if Romberg is notified of a request to take back the equipment.
- 11.4 Romberg has also created opportunities for users other than private households to take back and return waste appliances and dispose of them in accordance with s 19 ElektroG. The user can return these devices to Romberg free of charge by sending them back to Romberg by mail: Romberg GmbH & Co. KG, Altgeräterücknahme, Werner-von-Siemens-Str. 13, 25479 Ellerau.
- 11.5 If you wish Romberg to take back an old device, please send an e-mail to Romberg: info@romberg.de with the corresponding request. Upon receipt of the email, Romberg will send instructions for return, etc.
- 11.6 Before disposing of old devices, the user must delete his personal data on old devices so that they cannot fall into the hands of third parties. The user is responsible for this deletion of data
- 11.7 Romberg is registered as a producer of electrical and electronic equipment under the WEEE registration number 10286839 with the register of "stiftung elektro- altgeräte", Nordostpark 72, 90411 Nuremberg, Germany.
- 11.8 In accordance with s 18 of the Electrical and Electronic Equipment Act, it is possible to obtain information on the fulfillment of national recycling targets in accordance with ss 10 (3) and s 22 (1) of the Electrical and Electronic Equipment Act via the following link: https://www.bmuv.de/themen/wasser-ressourcen-abfall/kreislaufwirtschaft/statistiken/elektro-und-elektro-nikaltgeraete

12. Applicable law; contract language

12.1 A contract concluded between Romberg and the customer as well as the agreements made under it shall be governed by the laws of the Federal Republic of Germany. The UN Convention on Contracts (CISG - United Nations Convention on Contracts for the International Sale of Goods of 11 April 1980) is expressly excluded.
